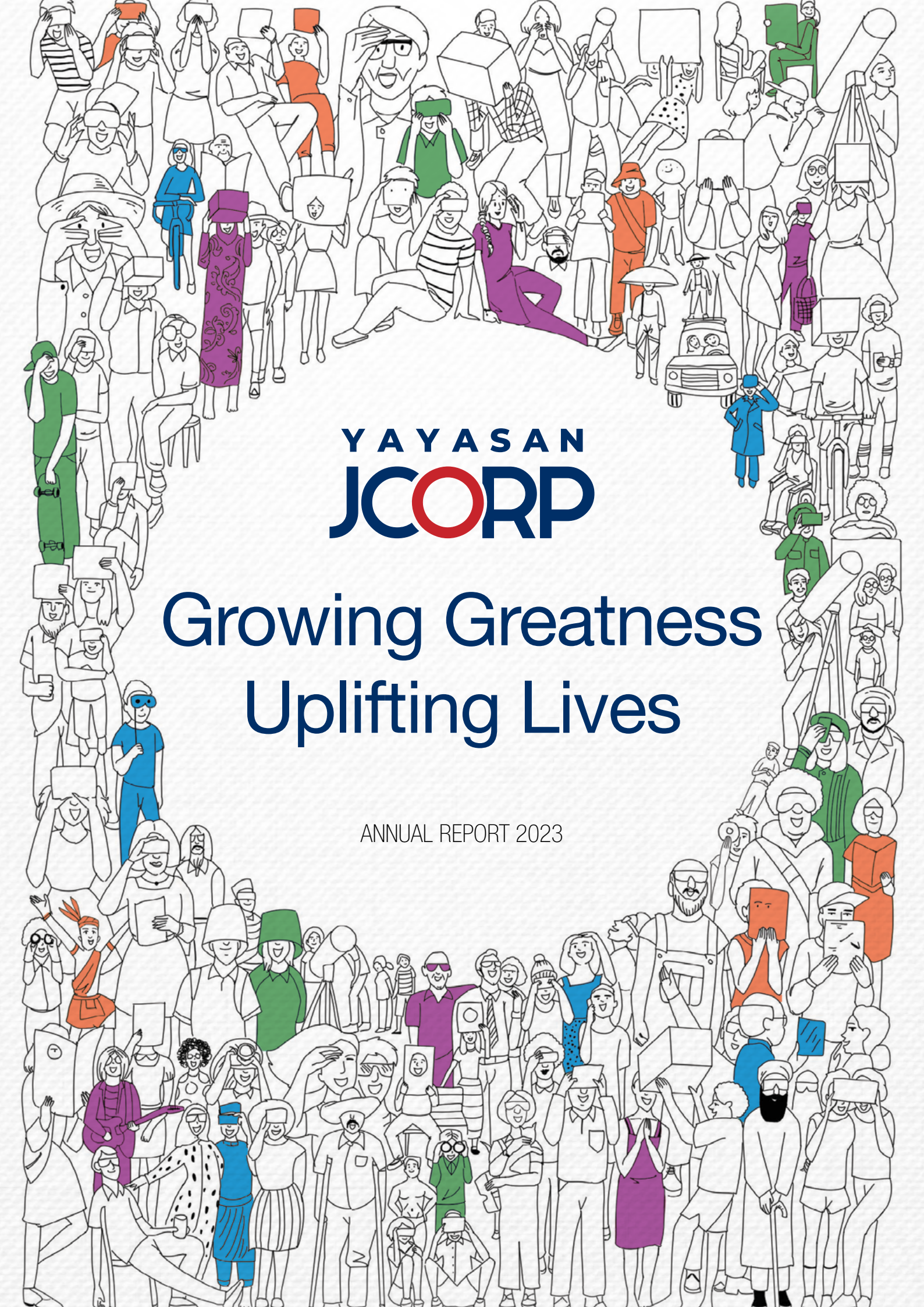

For more than 25 years, we have been empowering communities through education programmes focusing on skills development, employment, digital literacy and entrepreneurship, particularly for underprivileged B40 students. In making our programmes a success, we collaborate with a wide range of stakeholders including the Johor State Education Department, private corporations and more.

In 2023, our Education pillar has accomplished the following:

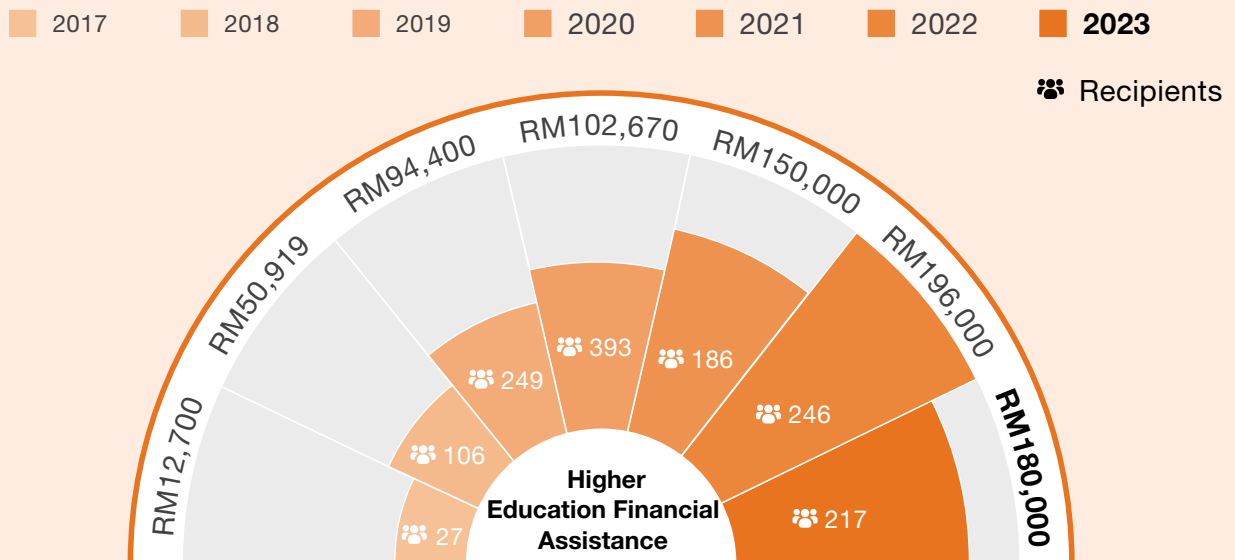

It is worth noting that Higher Education Financial Assistance continues to benefit the B40 families and students at higher education institutions nationwide by relieving their financial burden in pursuit of knowledge.

In 2023, we aided **217** B40 students, with an investment of **RM180,000**.

Over the years, more than **1,424** recipients have benefitted from our Education Financial Assistance, with an amount of **RM786,689** invested.

Pioneering the National Dual Training System (SLDN) Programme for Daily Secondary School in Malaysia

Yayasan JCorp signed an NoU with the Johor State Education Department (JNPJ) and QSR Stores Sdn Bhd in October 2023 to launch the SLDN Programme for daily secondary school in Malaysia to develop knowledge workers (K-workers) with technical, social, humanities and learning competencies. The SLDN programme entails 70-80% Practical Training (performance-based) while the remaining 20-30% is on Theory Learning (knowledge-based). The programme aims to provide alternative education, support the government's goal of developing a skilled local workforce, and enhance Yayasan JCorp's focus on education. It received technical support from the Department of Skills Development (JPK), Southern Region.

For this pioneering project, 12 students from SMK Tun Syed Nasir Ismail and 13 students from SMK Majidi Baru 2, Johor Bahru, were placed at six selected KFC restaurants in Johor for a two-year training programme in fast food preparation. The students underwent an induction programme at KFC Nusa Bestari Training Centre and received immunisation shots, uniforms and training allowances. Upon completion of the programme, the eligible apprentices will receive a certificate from QSR, a Malaysian Skills Certificate Level 3 from JPK, and MPAK and SPM certificates from the Ministry of Education.

Yayasan JCorp's involvement in the English language improvement programme started in 2012 through tuition projects conducted in selected schools in the state of Johor. It is also in line with the present development of various industries, which emphasises English for employment. During the year, we conducted various initiatives to uplift the level of English proficiency among students.

Financing Professional Accounting Education (ACCA Scholarship)

The education support programme at Yayasan JCorp plays a pivotal role in enhancing equity by extending opportunities to individuals who lack access to high-quality education. For almost eight years, we have been helping B40 students pursue their Association of Chartered Certified Accountants (ACCA) qualifications by

giving them scholarships. This ACCA educational sponsorship is a continuation of the JCorp Chartered Accountancy Programme initiative to support the development of human capital in professional fields in the country, involving an allocation of RM2.7 million.

6 Industrial Training Programme

Yayasan JCorp is dedicated to fostering a competent workforce through our Industrial Training Programme and skills-based initiatives. The main objective is to impart students with practical skills essential for today's job market. Furthermore, this initiative offers students

hands-on industrial training opportunities within the JCorp Group of Companies and other key partners. By doing so, the Foundation seeks to nurture skilled professionals and drive growth in various industries, particularly in Johor.

There are five categories of certifications:

Yayasan JCorp and JCorp's Group of Companies initiated a secondary school tuition project aimed at enhancing students' performance in the Sijil Pelajaran Malaysia (SPM) examinations.

Collaborating with the TVET Unit of the JPNJ, the project focused on Mata Pelajaran Elektif Ikhtisas (MPEI) such as Business, Economics, Accounting and English modules.

Forums can serve as a platform for communities to engage in discussions, share stories and exchange knowledge about history, culture and heritage. On 13 February 2023, Yayasan JCorp co-organised a forum titled “Empowering Identity through History, Culture, and Heritage” with the Johor State Education Department (JPNJ), with support from the Johor Heritage Foundation (YWJ) and the Malaysian Historical Society.

This programme marked the starting point of Yayasan JCorp’s focus on arts, culture and heritage in the reviewed year. Focusing on topics relating to identity, the history of Johor and the 11 identity points of Bangsa Johor, the forum received positive responses from both in-person and virtual participants. Continuing our work in this space for the future, we plan to collaborate with KPJ Healthcare Berhad to create art galleries at selected KPJ hospitals, especially in Johor.

Later in the year, we partnered with the Johor National Department of Culture and Arts (JKKN) and Johor Zapin Association (Pe-Zapin) to host the Zapin Yok! programme on 26 August. The programme showcased Johor Zapin variations with the concept of “Main Zapin” as a combination of sketch and theatre in Zapin dance, which attracted over 100 enthusiasts from around the nation. To engage visitors, a Zapin workshop was held to showcase 15 variations of the dance.

Additionally, the programme served as a platform for arts practitioners and artists to generate additional income as the event also featured food trucks and a car boot sale.

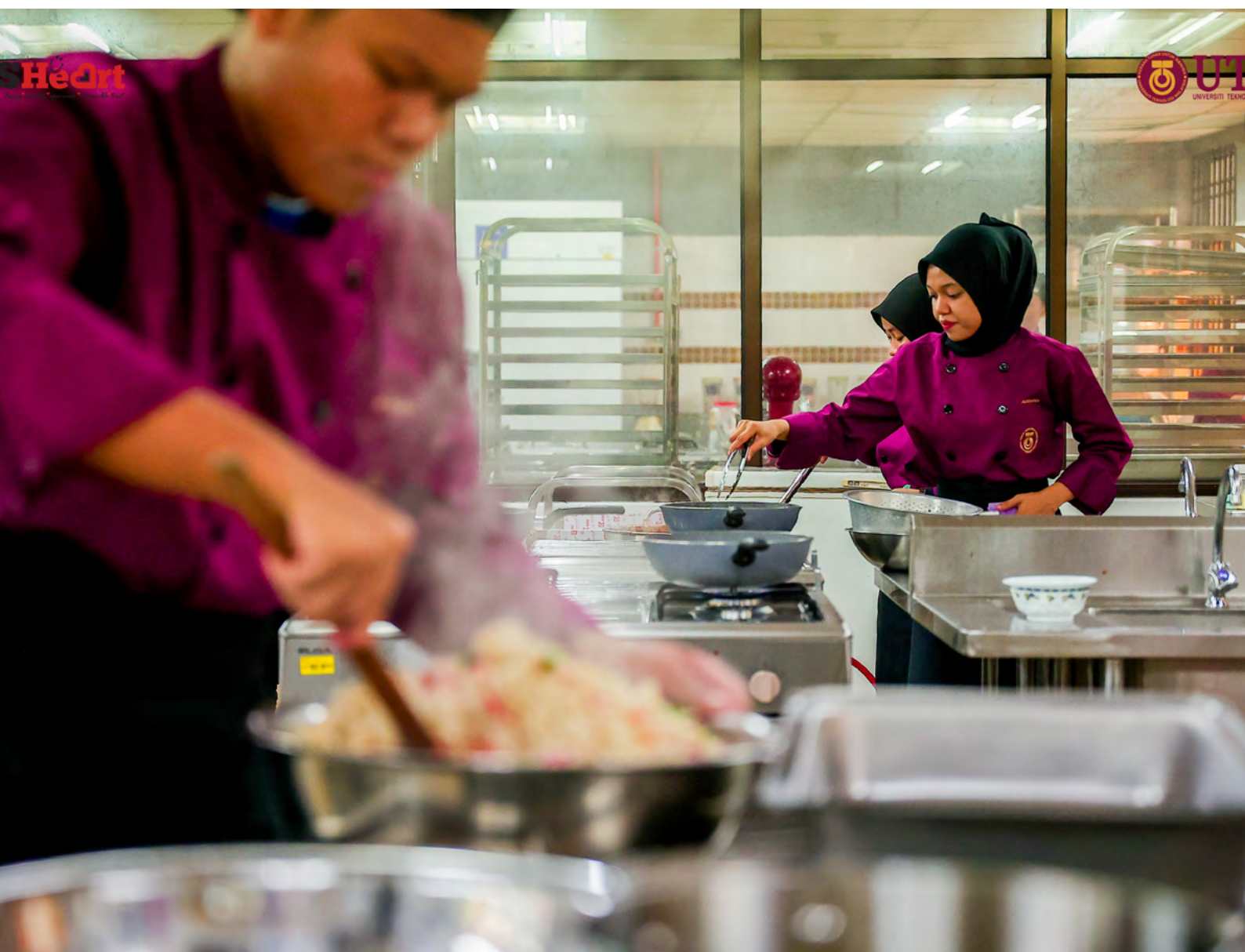

TRUSTEES' REPORT

The Trustees hereby present their report together with the audited financial statements of the Yayasan JCorp ("the foundation") for the financial year ended 31 December 2023.

1. OBJECTIVES

1. GENERAL INFORMATION

The main activity of the foundation is as a charity that receives, plans, manages and administers funds for education, art, culture & heritage, environment and community well-being purposes.

The foundation is a limited company with a guarantee that has been incorporated in Malaysia and therefore has no shares.

The registered address of the Company is Level 16, KOMTAR Tower, Johor Bahru City Center, 80000 Johor Bahru, Johor

The Company conducts its activities at Level 18, KOMTAR Tower, Johor Bahru City Center, 80000 Johor Bahru, Johor.

The financial statements of the foundation have been approved by the trustees on 24 March 2024.

2. BASIS OF PREPARATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of Preparation of Financial Statements

The financial statements of the foundation are prepared in compliance with Malaysian Financial Reporting Standards ("MFRSs"), International Financial Reporting Standards ("IFRSs") and the provisions of the Companies Act 2016 in Malaysia.

The financial statements of the foundation have been prepared on a historical cost basis, except when otherwise indicated.

The accounting policies adopted by the foundation are consistent with previous financial years, other than applying the amended MFRS as in Note 2.2 below.

2.2 Adoption of amendments to MFRS

The amendments also provide guidance on how an entity applies the Materiality Concept in making decisions about disclosure of accounting policies.

The amendments may affect the disclosure of accounting policies but not the measurement, recognition or presentation of any items in the Foundation's financial statements.

Income from donations is recognised upon receipt. Donations received are exempted from Income Tax under Section 44(6) of the Income Tax Act 1967.

2.5 Lease

The Foundation evaluates at contract inception whether a contract contains or includes a lease. This is, whether the contract conveys the right to control the use of an asset for a period of time in exchange for consideration.

(a) As Lessee

The Foundation employs standalone recognition and measurement approach for all leases, except short-term leases and leases of low-value assets. The Foundation recognises lease liabilities for lease payments and deliberates on the selection of leased assets as collateral.

(i) Right-of-use assets

The Foundation recognises right-of-use assets at the commencement date of the lease. Right-of-use assets are initially measured at cost, less accumulated depreciation and impairment losses, and adjusted for any re-measurement of lease liabilities. Cost of right-of-use assets include any lease liabilities recognised, initial direct costs incurred, and lease payments made before or after the commencement date net of any lease incentives received. Right-of-use assets are depreciated according to the straight-line method over the shorter of the asset's useful life and the lease term.

(ii) Lease liabilities

From the commencement date of lease, the Foundation recognises lease liabilities at the measured value of the payments made throughout the lease period. Lease payments include fixed payments minus any lease incentives received, variable payments depending on indices or rates, and amounts expected to be paid under remaining guarantees. Lease payments also include the exercise price of options that the Foundation will certainly execute, and penalties for lease terminations, except where the Foundation is certain not to exercise the option to terminate the initial lease contract.

In calculating the value of lease payments, the Foundation uses the additional borrowing rate at the commencement date of lease because the implicit rate of the lease cannot be determined.

After the commencement date, the amount of lease liabilities will increase due to accrued interest and decrease when lease payments are made. The initial amount of lease liabilities is measured at inception unless modifications occur, such as changes in payment amounts, lease periods, and changes in the assessment of options to purchase collateral assets.

(iii) Short-term leases and leases of low-value assets

The Foundation chooses not to recognise deferred lease assets and liabilities for short-term leases with a duration of 12 months or less and leases of low-value assets. The Foundation recognises these leases payments as expenses on a straight-line basis over the lease period.

(b) As Lessor

For each lease class, the Foundation conducts an overall assessment of the leasing, transferring all associated ownership risks of the collateral assets. If this occurs, the lease is a financial lease; if not, it is operational lease. Initial direct costs incurred in negotiating an operational lease are included in the initial amount of leased assets recognised over the lease term on the same basis as rental income.

3. FUNCTIONAL CURRENCY AND PRESENTATION

The elements in the financial statements of the foundation are valued using the principal currency of the operating entity ("functional currency"). Ringgit Malaysia is the functional and presentation currency of the foundation in the financial statements.

According to a letter from the Inland Revenue Board dated 30 March 2021, the approval period for the foundation under subsection 44 (6) of the Income Tax Act 1967 is 5 years until 31 December 2025.

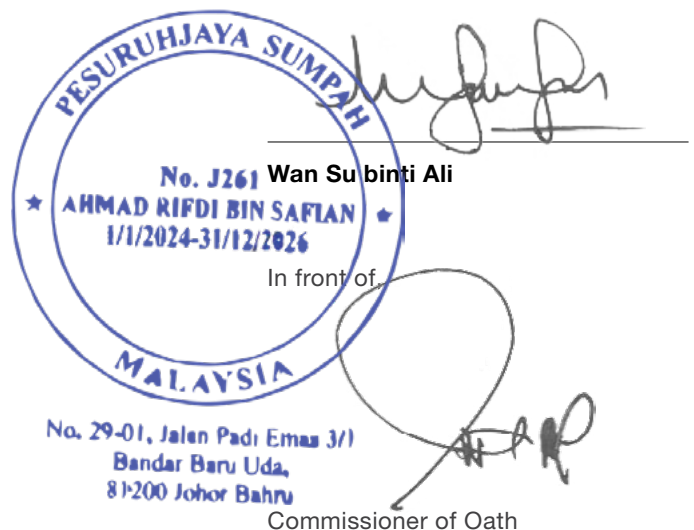

Our opinion on the financial statements of the foundation does not include other information and we do not express any form of assurance of conclusions thereon.

In relation to our audit of the foundation's financial statements, our responsibility is to interpret other information and, in doing so, consider whether there is other information that is material and inconsistent with the foundation's financial statements or differs from information obtained during the audit, or there is a material misstatement.

If, based on the work we have performed, we conclude that there is a material misstatement of the other information, we are required to report that fact. In this case, we do not have any facts to report.

AUDITOR'S REPORT TO THE MEMBERS

Trustee's Responsibility to the Financial Statements

The foundation's trustees are responsible for preparing financial statements that give a true and fair view based on Malaysian Financial Reporting Standards, International Financial Reporting Standards and the provisions of the Companies Act 2016 in Malaysia and establishing such internal control systems as necessary to enable the preparation of the financial statements are free from any material misstatement, whether due to fraud or error.

In preparing the financial statements of the foundation, the trustee is responsible for assessing the foundation's ability to continue operations on an ongoing basis, disclosing where applicable, matters relating to going concern and applying the accounting basis of going concern, unless the trustee intends to dissolve the foundation or to discontinue operation, or have no realistic alternative except to do so.

Auditors' Responsibility for the Audit of Financial Statements

Our objective is to obtain reasonable assurance as to whether the financial statements of the foundation as a whole are free from material misstatement, whether due to fraud or error and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but not a guarantee that an audit conducted in accordance with approved auditing standards in Malaysia and International Standards on Auditing will always detect a material misstatement when it exists.
